## Support the Trade Reform, Accountability, Development and Employment (TRADE) Act

March 1, 2010

**Dear Member of Congress:**

On behalf of our tens of thousands of Latin America policy advocates across the country, we ask you to support the *Trade Reform, Accountability, Development and Employment (TRADE) Act* and add your name as a cosponsor. Introduced by Rep. Mike Michaud (HR 3012) and Sen. Sherrod Brown (S 2821), this bill has now gained support from a majority of House Democrats, along with the institutional backing of hundreds of diverse faith, farm, labor, consumer, and environmental groups.

The TRADE Act charts policy space for a more balanced and just approach to trade. It maps a forward-thinking alternative to the discredited NAFTA model, articulating the sort of trade that would create, not erase, jobs.

With offices in the United States, Mexico, and Nicaragua, we have spent over a decade observing firsthand the manifold impacts of trade deals such as the North American Free Trade Agreement (NAFTA) and Central America Free Trade Agreement (CAFTA). Trade should serve the interests of the majority on issues such as wages, public health, the environment, food security, consumer safety and access to essential services. Instead, NAFTA-style pacts have erased scores of decent U.S. jobs and built downward pressure on domestic wages. In Mexico and Central America, the deeply asymmetrical agricultural stipulations of these trade agreements have displaced millions of small-scale farmers, fostered dependency on fickle and exploitative assembly industries, and forced unprecedented numbers to migrate to the U.S. Meanwhile, the trade agreements' sweeping investment provisions have restricted access to life-saving medicines, threatened access to water and other essential services, and subverted democratically-enacted environmental protection laws to the narrow interests of investors.

The TRADE Act would take significant steps toward mending these flawed agreements and ensuring that future ones promote good jobs, public health, food security, and environmental sustainability.
